_____ I acknowledge and understand that there are inherent risks involved in day care and boarding, including but not limited to rough play, dog fights, dog bites to humans or other dogs, injuries: scrapes/scratches, cuts, punctures, strains, sprains, broken bones, fatigue, death, and the transmission of disease: viruses, parasites, development of kennel cough even with current vaccination. I understand that not each potential risk factor can be listed, but I agree that the benefits of daycare, boarding, and socialization outweigh the possible risks. Any medical expenses will be my responsibility and I release Newara's Dog House of any charges.

_____ I release, indemnify, and agree to hold Newara's Dog House harmless from any and all manner of damages, claims, loss, liabilities, costs or expenses, causes of actions or suits, whatsoever in law or equity, (including, without limitation, attorney's fees and related costs) arising out of or related to the services provided by Newara's Dog House, except which may arise from the sole gross negligence or intentional and willful misconduct of Newara's Dog House, including, without limitation, (i) any inaccuracy in any statement made by yourself or information provided by you to Newara's Dog House (ii) your dog, including but not limited to destruction of property, dog bites, injury, and transmission of disease, and (iii) any action by yourself which is in breach of the terms and conditions of this agreement.

_____ I further understand that I may be exposed to risks when dropping off or picking up my dog at Newara's Dog House. Certain risks may include: physical injury, dog bites, scratches, falling, slipping, property damage, or illness. I voluntarily release, agree to hold harmless, and indemnify Newara's Dog House and its staff or agents from all liability and claims.

_____ I agree to provide 24 hour notice of cancellation if my dog will not be attending daycare as scheduled (7 day notice of cancellation for boarding). I understand that failure to cancel daycare by or before 24 hours of the scheduled date will result in the charge of a full day of daycare. All charges must be paid in full upon pick-up of your dog. We accept cash, check, credit, or debit made out to Newara's Dog House. \$50 returned check fee applies.

_____ I agree to drop off and pick up my dog within normal business hours, and I understand that \$25 early/late fees will apply for before/after hour care of my dog. I understand that if I am over 30 minutes late for pick up, my dog must board until normal business hours resume the following day. All daycare drop offs must be between the hours of 7:00am-9:00am only, M-F.

_____ I understand that photos and videos taken at Newara's Dog House may be used online and on social media sites.
