Newara's Dog House Policies

*** Please Read & Initial Each Section ***

By submitting this form, you indicate your agreement with all the terms listed hereof:

Emergency Medical Care: If, in our judgment, your dog requires immediate medical care and we are unable to reach you, we will take your dog to a veterinarian or animal hospital.

Initials ____ By initialing here, you agree to be solely responsible for the payment of all medical bills for your dog and you release **Newara's Dog House**, its officers, directors, agents, volunteers, and employees of and from any and all responsibility for, or claims, damages, debts, arising out of or related to such medical care, including, but not limited to, transportation to/from the veterinary clinic and choice of veterinarian and animal hospital.

____ Newara's Dog House reserves the right to immediately change your dog's type of boarding/daycare if we believe it is necessary to protect the health and well-being of your dog, other dogs, or our staff. I understand that Newara's Dog House reserves the right to decline participation or to terminate participation in doggy daycare or boarding at any time for any reason.

____ All dogs must be healthy, and current on all vaccinations. You will be required to bring a copy of your dog's updated vaccination records from your vet before you start daycare or board with us to ensure your dog's safety as well as that of our existing Newara's Dog House dogs.

____ If your dog is exhibiting any symptoms that may suggest illness such as sneezing, coughing, wheezing, runny eyes or nose, vomiting, lethargy, or diarrhea, please do not bring your dog to daycare or boarding. If your dog comes into heat while boarding you will be charged an extra \$25 per day. Dogs with flea or tick problems will be treated with a Capstar tablet, at the owner's expense (\$15/day).

____ I acknowledge and understand that there are inherent risks involved in day care and boarding, including but not limited to rough play, dog fights, dog bites to humans or other dogs, injuries: scrapes/scratches, cuts, punctures, strains, sprains, broken bones, fatigue, vomiting, diarrhea, upset stomach, dehydration, bloat, death, and the transmission of disease: viruses, parasites, development of kennel cough even with current vaccination. I understand that not each potential risk factor can be listed, but I agree that the benefits of daycare, boarding, and socialization outweigh the possible risks. Any medical expenses will be my responsibility and I release Newara's Dog House of any charges.

____ I release, indemnify, and agree to hold Newara's Dog House harmless from any and all manner of damages, claims, loss, liabilities, costs or expenses, causes of actions or suits, whatsoever in law or equity, (including, without limitation, attorney's fees and related costs) arising out of or related to the services provided by Newara's Dog House, even which may arise from the sole gross negligence or intentional and willful misconduct of Newara's Dog House, including, without limitation, (i) any inaccuracy in any statement made by yourself or information provided by you to Newara's Dog House (ii) your dog, including but not limited to destruction of property, dog bites, injury, and transmission of disease, and (iii) any action by yourself which is in breach of the terms and conditions of this agreement.

____ I further understand that I may be exposed to risks when dropping off or picking up my dog at Newara's Dog House. Certain risks may include: physical injury, dog bites, scratches, falling, slipping, property damage, or illness. I voluntarily release, agree to hold harmless, and indemnify Newara's Dog House and its staff or agents from all liability and claims.

____ I agree to drop off and pick up my dog within normal business hours. If my dog is not picked up by the end of business hours on any given day, I authorize Newara's Dog House to provide after-hours care and I agree to pay the fees for after-hour care. I understand that if my dog is not picked up within 30 minutes after the end of business hours, I will be required to pick up my dog the following day when normal business hours resume. Any dog left 24 hours after scheduled pick up date/ time will be considered to be abandoned, will become property of Newara's Dog House, and may be disposed of at Newara's Dog House's discretion.

____ I agree to provide 24 hour notice of cancellation if my dog will not be attending daycare as scheduled. I understand that failure to cancel daycare by or before 24 hours of the scheduled date will result in the charge of a full day of daycare. All boarding cancellations require 7 day notice or charge of one full day of boarding will result. Newara's Dog House reserves the right, without notice, to adjust its fees for services.

____ All charges must be paid in full upon pick-up of your dog. I understand that my dog will not be released from Newara's Dog House unless payment is made in full. Newara's Dog House accepts cash or check. \$50 returned check fee applies.

____ Changing a dog's food can cause upset stomach, owners are to bring their dog's food from home. Owners are welcome to bring their dog's own bedding or toys if desired, however we cannot guarantee that they will be returned in the same condition.

____ Photos taken at Newara's Dog House may be used online and on social media sites. No personal information will be disclosed.

____ Newara's Dog House reserves the right to transport your dog by motor vehicle when deemed necessary, including, but not limited to, transportation to/from Newara's Dog House, to veterinary clinic, home, etc. Additional mileage fee may apply.

____ This agreement covers the current relationship between Newara's Dog House and yourself. Each time you bring your dog to Newara's Dog House, you affirm the terms of this Agreement, and the truthfulness and accuracy of all statements you make in this Agreement.
