_____ I acknowledge and understand that there are certain risks involved in grooming, including but not limited to scrapes, scratches, cuts, irritation of existing conditions (hot spots, skin allergies, matting of fur, etc), allergic reactions, quick/nerve in nail becoming exposed resulting in light to moderate bleeding, dog bites to humans, and the transmission of disease: viruses, parasites, development of kennel cough even with current vaccination. Any medical expenses will be my responsibility and I release Newara's Dog House LLC of any charges.

_____ I further understand that I may be exposed to risks when dropping off or picking up my dog at Newara's Dog House LLC. Certain risks may include: physical injury, dog bites, scratches, falling, slipping, property damage, or illness. I voluntarily release, agree to hold harmless, and indemnify Newara's Dog House LLC and its staff or agents from all liability and claims.

_____ I understand that if my dog becomes overly nervous, stressed, or displays aggressive behavior (biting, growling, scratching, etc.), I will be charged an additional \$15 challenging handling fee. Newara's Dog House LLC may stop grooming services for safety of dog and groomer.

_____ In order to remain a clean and parasite free facility, for the health and safety of all dogs, we cannot accept dogs with fleas. If fleas are noticed on dog, owner will be contacted immediately and dog will need to be picked up immediately. Owner will be subject to \$25 cleaning fee.

_____ I understand that if my dog is severely matted, groomer may need to completely shave down areas of dog or the dog in entirety. \$15-\$25 matting fee will apply

_____ I agree to provide 24 hour notice of cancellation if my dog will not be attending his/her grooming appointment. I understand that failure to cancel grooming by or before 24 hours of the scheduled service or no call/no show will result in verbal warning on the first offense, a full charge for grooming service scheduled on the second offense, and if third offense occurs, dog will no longer be eligible to receive grooming services at Newara's Dog House LLC.

_____ All charges must be paid in full upon pick-up of your dog. We accept credit, debit, cash or check made out to Newara's Dog House. \$50 returned check fee applies.

_____ I agree to drop off and pick up my dog within normal business hours, and I understand that a boarding fee may be applied if I cannot pick my dog up from his/her grooming appointment during business hours. Any dog left over 24 hours after scheduled service will be considered abandoned, will become property of Newara's Dog House LLC, and may be disposed of at Newara's Dog House LLC's discretion.

_____ Photos and videos taken at Newara's Dog House may be used online and on social media sites. No personal information will be disclosed.

_____ *** For all dogs' and humans' safety, all dogs must be on leash and under control while on NDH property*** We have 3 office kitties, please let us know if your dog does not do well with cats.
